In the event of a cancellation of a confirmed booking by the client, the booking fee is not refundable.

In the event of mechanical failure, due to circumstances beyond their control, EH Limo Hire reserves the right to substitute vehicles of equal capacity.

EH Limo Hire can not be held responsible or liable for any loss or damage to the clients and passengers property, howsoever caused.

The chauffeur reserves the right to refuse the carriage of luggage if in his judgment the volume or weight is excessive for the vehicle.
